- DSHS Tasked CATRAC to continue COVID Response thru August
 - Seek approval for every dollar spent



- Region 7 Regional Calls
 - CAMOC calls with Randy Crutsinger for all Healthcare Facilities, Long Care Facilities, Dialysis, Emergency Management, etc. to bring situational awareness
- ATC Executive Leadership Calls
 - 130% increase in hospitalizations across all 4 TSA's
 - Infections of unvaccinated
 - Delta Variant transmissions by individuals that are vaccinated
 - 12 STAR requests for Staffing (100's of nurses)

 - Neonatal & Maternal going smoothly
 - Feedback mechanism (RAC PCR Alliance)
 - 22 RACS across state
 - Help Quality Improvement
- Ongoing Neonatal Temperature Project
 - CDC designated Quality Improvement Project
 - o 70% of deliveries in state registered for this project
 - 1st data collections at end of month
 - Start with intervention in January and Collect Data for 18 months
 - Objective: 50% increase in number of euthermic infants delivered in hospitals across the state
 - Race and ethnicity also considered
- Putting together a group to discuss a screening process for CMV hearing loss in infants
- Putting together a subcommittee to improve neonatal transport and staff communication between systems
